According to USDA Forest Service Research, wood bark, such as fine ground redwood bark, is an excellent soil conditioner, lending body to sandy or silt soils, loosening up clay soils, providing aeration to heavy soils, and increasing water retention and root penetration in all soil types. Fine ground, FSC Certified, California grown redwood bark helps conserve moisture through weed control, temperature stabilization and reduced evaporation while minimizing topsoil erosion and also benefiting soil microflora.

When compared against traditional soil amendments, namely Sphagnum Peat Moss and Coconut Coir, Emerald Peat is the environmentally sound substitute. Key benefits include:

- **100% American-made Emerald Peat** compared to Sphagnum Peat Moss and Coconut Coir imported from Canada and Asia
- **100% Renewable Emerald Peat** compared to Sphagnum Peat Moss bogs which gain less than a millimeter in depth each year
